156. **THE QUEEN'S PLATINUM JUBILEE CELEBRATIONS** - Councillor Mrs. Salt requested this in the agenda and the Clerk reported she had received lots of information about funding for events which she has passed on. Councillor Mrs. Hartley stated that there is a meeting at Wetley Rocks Village Hall next week, which she will attend. St. Andrews and the Scouts have approached Councillor Mrs. Salt want to join in. The Clerk suggested a meeting to advertise to residents in Cheddleton Community Centre.

- 157. UPDATE STREET LIGHT - ASHCOMBE ROAD, CHEDDLETON** - The Clerk that the Light has been done but as, yet we have not received a bill from EON. The shield has not been put on it to deflect the light from the residents. Once completed the Clerk will report back.
- 158. CONFIRMATION OF PRECEPT 2022/23** - The Clerk reported that SMDC have calculated the Band D charge will be £35.54 which is an increase of 14.09% based on 2021/22 precept.
- 159. PROPOSED BATTERY ENERGY STORAGE SYSTEM – SIRIUS RENEWABLE ENERGY** - The Clerk had received information from another potential planning application and requested feedback from the Parish Council which have been circulated to members. Councillor Mrs. Lovatt stated that these are to make money for the landowners and the number of applications that SMDC are receiving for our Parish is ridiculous and will destroy our greenbelt. After some discussion it was agreed that as a green issue its not benefiting our Parish specifically and desecrating our greenbelt. Councillor Boden reported that as a younger Councillor the race is to complete the deadline of becoming greener and the government is backing projects to try and meet deadlines without thinking of the consequences as a heating engineer looking at moving away from gas for householders heating which is trying to make wins quickly. Councillor Bowen added in some areas there is no way that they can meet the knee jerk reactions that the government are looking at becoming carbon neutral as there are areas in the country that have not even got the choice as it will not be available.
- 160. UPDATE ON FOOTPATH VOLUNTEER EXPENSES** - The Clerk reported that a claim was submitted to Staffordshire County Council for one of our volunteers and has finally been paid that has been outstanding since September 2021.
- 161. UPDATE OVERHANGING TREES RANGLES LANE, WETLEY ROCKS** - The Clerk reported on Rt. Hon. Karen Bradley M.P. requesting further information about the ongoing issues with the Diocese. The Clerk has responded with details requested and agreeing that some works are required on the trees and need permission to do the works and who is responsible.
- 161. a. FURTHER FLY-TIPPING COALPITFORD LANE** - The Clerk reported that Councillor Boden has reported yet another Fly Tip of Cannabis plant remnants and equipment. All details have been reported to the Police and SMDC.
- 161. b. NESTING BOXES FOR FOOTPATH 38** - The volunteers have approached The Clerk to provide a dozen new nesting boxes to be situated in the woods now that works are coming to the end for this season to encourage birds to nest. The Clerk has contacted various authorities for donation of this, but they need to be put up soon for use this year. It was suggested contacting Leek College and proposed that, if necessary, the Council pay for them by Councillor Jennings, seconded by Councillor Mrs. Salt and all members agreed.
